## SPACE COAST YOUTH TOURNAMENT RULES

**1. ELIGIBILITY:** This tournament is USBC-certified and is open to all active, currently sanctioned USBC Youth members

**2. TOURNAMENT FORMAT:** This tournament shall consist of 3 events for all 4 divisions and will be conducted on an average basis REGARDLESS OF AGE. All participants will bowl three (3) games for each event. The Individual average breakdown for divisions are as follows: 1) 175 & OVER 2) 150-174 3) 120-149 4) 119 & UNDER  
Any division with fewer than 5 entries will be combined with an adjacent average division.

**3. Teams** shall consist of four bowlers. Team and Doubles may consist of any combination of girls and boys. Each bowler may bowl in Singles and Doubles events once. Anyone bowling Singles must also bowl Doubles and vice versa. Teams shall consist of four bowlers. Team and Doubles may consist of any combination of girls and boys. Each bowler may bowl in Singles and Doubles events once. Anyone bowling Singles must also bowl Doubles and vice versa. A youth bowler may enter in the team event more than once provided that a minimum of 2 bowlers is replaced on any roster. The 1st team event bowled will count towards their all events.

**4. ENTERING AVERAGE:**

- A. Entrants will use the highest USBC certified average for the 2025-2026 league average of 12 games or more as of January 1, 2026, converted averages will be used if only Sport and Challenge shot averages exist for a bowler
- B. Bowlers not having an average as specified above will use a current average of 12 games or more at the time of bowling, converted averages will be used if only Sport and Challenge shot averages exist for a bowler
- C. Bowlers with neither of these averages will use a summer 2025 average of 12 games or more, converted averages will be used if only Sport and Challenge shot averages exist for a bowler
- D. Bowlers not having any of these averages will bowl SCRATCH.

**USBC Rule 319a (2) DOES APPLY (10 PIN RULE)** up to and including league averages as of **February 14, 2026**

**It is the responsibility of the League Coach/Secretary/Director to certify and provide the Tournament Manager with eligible averages.** Send eligible averages with entry form and late averages **1 week** before bowling.

**5. HANDICAP:** Handicap will be 90% of the difference between the bowlers entering average and 210.

**6. ENTRY FEE:** Entry fee is \$35.00 per Bowler, per event. Lineage & expenses are \$16.00 and Prize fund is \$19.00 for Team, Doubles and Singles Events. All participants will bowl three games for each event. **Any bowler that enters all three events will automatically be entered into the Handicap All Events at no extra charge. Optional all events scratch is available in all divisions for \$5.00 per bowler.** There will be **NO REFUNDS** after entry deadline of February 1, 2026 **Walk-Ins: There will be no walk ins allowed**

**7. ENTRY DEADLINE: FEBRUARY 1, 2026** - ENTRIES MUST BE POSTMARKED OR DELIVERED TO THE TOURNAMENT MANAGER BY THE ENTRY CLOSE DATE. **No entry accepted without the entry fee** (MONEY ORDER, ZELLE, CHECK, CERTIFIED CHECK OR CENTER CHECK ONLY). **Make checks payable to: Space Coast USBC BA**

**8.** Bowlers will bowl in the order listed on the entry form. Change in the computer line-up is not allowed. Substitutes are allowed and will bowl in the same line-up position.

**9.** All entrants must report at least 45 minutes before squad time. If any changes or substitutions, the Team Captain or Coach must report to the Tournament Manager at least 1 hour before squad time.

**10.** Team Captains or Coaches must sign the entry form for verification of line-up.

**11.** Scholarships shall be awarded in each division for each event, including All Events, based on one scholarship per 5 entries. There will be scholarships for boys and girls in both Singles and All Events. In case of a tie for first place duplicate awards will be given and co-champions declared. Scholarship fund returned 100%.

**12.** Report any appeal or protest regarding scores or eligibility to the Tournament Manager or Director **IN WRITING** within 72 hours after any error or infraction has occurred. Errors in posted results must be reported, in writing, within 72 hours to the Tournament Director. Any protest or appeal affecting the playing rules or eligibility must be confirmed in writing to a tournament or local association official, or the United States Bowling Congress BEFORE the tournament prizes are awarded. Rule 329 addresses protest and appeals. All protests would be filed with tournament management within 72 hours of the infraction, or prior to tournament prizes being awarded, whichever occurs first. All appeals would be submitted within 10 days of notification of tournament management's decision on the protest.

**13. TARDY BOWLERS:** Bowlers who miss one or more frames by not being present and ready to bowl when it is their turn, shall be credited with zero (0) pins for those frames missed

**14. ONLY TOURNAMENT OFFICIALS** are allowed to correct scoring errors. Center score printouts take precedence if different scores recorded on manual score sheets turned in to officials.

**15. DRESS CODE:** Appropriate bowling attire is required. No halters, tank tops, or head apparel will be permitted. No hats, headphones, electronic devices (with the exception of ear buds) may be worn on the lanes by bowlers. Shorts, skorts, or skirts must be longer than your fingertips when placed at your side. All pants will be worn at the waist level with no underwear or bare skin showing. Refer to USBC dress code for proper attire. **No exceptions.**

**16. OFFICIALS & RVPs:** Coaching will be allowed outside of the bowling circle. Only participating Athletes, Tournament Staff, Registered Volunteers (wearing RVP credentials), Youth Directors, and Bowling Center Personnel are allowed in the bowling circle

**17.** Any rules not covered above shall be governed by USBC Rules.

## **ROLL & GROW RULES & ENTRY**

1. Bowlers (age 6 and under) must be a current member of a Roll & Grow certified league at a center serviced by the Space Coast B.A., USBC Youth.
2. **ENTRY FEE** is \$12.00 per Bowler. Lineage & Expenses are \$8.00 and Prize fund is \$4.00.
3. There is only a Singles event with one (1) division. Handicap 90% of 190
4. Entering average is the bowler's current season average as of 1/1/2026. Bowlers without a 1/1/2026 average may use current average at time of bowling.
5. Awards are based on one (1) award per five (5) entries. In case of a tie for first place duplicate awards will be given and co-champions declared. Scholarships will be awarded in the Roll & Grow Division to all bowlers.
6. The series is based on two (2) games.
7. All general rules from above will be followed.

This Roll & Grow Division allows our youngest bowlers that are using the bumpers, to become used to tournament bowling at the start of their bowling careers. It will allow them to become acquainted with bowling in different centers in a format that will not intimidate or tire them.

We hope they will enjoy themselves and learn something too. Please let us know how your Roll & Grow bowlers feel about his/her experience. We appreciate your input.

The bowlers will bowl 2 games of Singles. They will have bumpers and scoring will be the same. **All bowlers must be current season sanctioned bowlers, a minimum age of 1 at 8/1/2025 and currently in a Bumper League.**  
Coaches need to verify their averages before they can bowl.

### ***ADDENDUM TO INCLUDE JUNIOR GOLD QUALIFIER***

To participate in the Junior Gold Qualifier for this event, you must already be registered to bowl in the tournament on/or before the deadline of 2/01/2026.

No walk-ins

Junior Gold: Qualifying will occur in compliance with the USBC Handbook.

Junior Gold qualifying ratio is 1 in 4 (no major fraction thereof). **Junior Gold Qualifier Entry Fee will be \$62.50 for U18 & U16, \$50.00 for U14, and \$37.50 for U12.**

Entrants must have purchased a Junior Gold membership prior to the start of the competition. (this is an additional USBC membership fee) See Bowl.com for prices (or below).

Scratch scores from the last game of the doubles session plus the 3 games of the singles session. (4 game series) are used for this Junior Gold qualifying.

In the event of a tie for an advancing position a one game roll-off will be conducted following completion of the tournament at a date, time and location to be determined.

Divisions may be combined if there are fewer than 4 entrants in an age/gender division. Divisions are determined by bowler's age on August 1, 2025.

**These membership fees are in addition to the entry fee for the tournament.**

- \$25.00 for U12 Junior Gold qualifier (DOB between 8/1/2013 - 7/31/2015)
- \$40.00 for U14 Junior Gold qualifier (DOB between 8/1/2011–7/31/2013)
- \$50.00 for U16 Junior Gold qualifier (DOB between 8/1/2009–7/31/2011)
- \$50.00 for U18 Junior Gold qualifier (DOB between 8/1/2007–7/31/2009)
