ENTRY DEADLINE: January 3th, 2026

SPACE COAST SENIOR TOURNAMENT RULES

- 1. **ELIGIBILITY:** You may enter the tournament if you have a current 2025-2026 USBC Membership, All participants must be 50 years or older. Entrants must have reached their 50th birthday by **January 16, 2026**. PBA / PWBA MEMBERS: There shall be no more than (2) PBA/ PWBA members allowed on each team and only one (1) PBA/PWBA member per doubles event.
- 2. **TOURNAMENT FORMAT:** Tournament will consist of a Team Event (4 person) and Doubles Event (2 person). MULTIPLE PARTICIPANTS:
 - a.) Team Event Bowlers must change two people each time you participate in a team event.
 - b.) Doubles Bowlers must change partners when participating more than one time.

3. ENTERING AVERAGE:

- a.) Entrants will use the **HIGHEST 2024-2025 AVERAGE OF 21 GAMES OR MORE**, converted averages will be used if only Sport and Challenge shot averages exist for a bowler
- b.) If "a" does not apply, the bowler will use the highest 2023-2024 average of 21 or more games, converted averages will be used if only Sport and Challenge shot averages exist for a bowler
- c.) If neither "a" nor "b" apply the bowler will use their highest current average as of January 10, 2026 of 21 games or more.
- d.) If none of the above apply the bowler will bowl scratch.
- USBC Rule 319a (2) DOES APPLY (10 PIN RULE) enforced as of January 10, 2026
- USBC Rule 319e "AVERAGE ADJUSTMENT FOR ENTRY" will apply.
- 6. HANDICAP: Handicap will be 90% of the difference between the bowlers entering average and 240.
- 7. ENTRY FEE: Entry fee is \$35.00 per Bowler, per event for Team, and Doubles. (Lineage & expenses are \$16.00 and Prize fund is \$19.00) Forms of payment are: cash, check, money order or Zelle to: association.manager@scusbcba.com.

Optional ALL EVENTS Handicap and Scratch are \$15.00 each. Bowlers may choose to enter both, one or neither of the All Events. All Events prize fund is \$14 with \$1 going toward expenses.

Optional TEAM SCRATCH EVENT, DOUBLES SCRATCH EVENT are \$10.00 each per bowler. Bowlers may choose to enter both, one or neither of the Scratch Events. For the Team Scratch and Double Scratch Event, **all bowlers** must choose to enter to be considered for this event. Scratch prize fund returned 100%.

Walk-Ins: Will NOT be accepted. Entry deadline: January 3, 2026

- 8. **REFUND:** There will be NO refunds, after January 3, 2026
- PRIZE REPORTING: USBC Rule 319d "REPORTING PRIOR PRIZE WINNINGS" has been waived.
- 10. **REPLACEMENTS:** Substitutes will be allowed. Substitutes will bowl in the position of the absent bowler as submitted on the application provided the entrant does not violate rule #1 & #3 a thru d.
- 11. **BOWLER'S RESPONSIBILITY:** Bowlers are responsible for verifying their own average, whether submitted by the bowler, the team captain or others. If the submitted average is lower than required and results in more handicap, **the bowler's score will be disqualified**. If the submitted average is higher than required, prize winnings will be based on the submitted average
- 12. **TARDY BOWLERS:** Bowlers who miss one or more frames by not being present and ready to bowl when it is their turn, shall be credited with zero (0) pins for those frames missed.
- **13. Team Captain** is responsible for notifying all entrants of dates and times they are scheduled to bowl and must check in all team members at least 45 minutes prior to squad time.
- 14. Errors in posted results must be reported, in writing, within 72 hours to the Tournament Director. Any protest or appeal affecting the playing rules or eligibility must be confirmed in writing to a tournament or local association official, or the United States Bowling Congress BEFORE the tournament prizes are awarded. Rule 329 addresses protest and appeals. All protests would be filed with tournament management within 72 hours of the infraction, or prior to tournament prizes being awarded, whichever occurs first. All appeals would be submitted within 10 days of notification of tournament management's decision on the protest.
- 15. **PRIZE DISTRIBUTION (for each Division):** Prize money for TEAM and DOUBLES & SCRATCH DIVISIONS will be distributed at a ratio of one for every five (1:5) entries and ALL EVENTS will be distributed at a ratio of one for every ten (1:10) entries.
- **16. 15. DRESS CODE:** Appropriate attire is required. .There will be NO tank top shirts allowed. Tournament management reserves the right to make final decisions on dress code.
- 17. Any rules not covered above shall be governed by USBC Rules.
