## SPACE COAST SINGLES CHAMPIONSHIP RULES

1. **ELIGIBILITY:** Open to all members of the SCBA. Entrants must show current USBC BA membership card or must pay USBC dues for a current membership card prior to bowling. Members living within the jurisdiction of this association who are members of another BA or WBA association and do not have a local SCBA membership may enter by purchasing a local SCBA card for \$12.00. A nonresident who is eligible for the association tournament must have 21 games or more in the SCBA to be eligible to compete in the Space Coast Singles Championship.
2. **TOURNAMENT FORMAT:** Tournament will consist of bowling 6 games across 6 lanes. **Pattern:** Titanium 4244
3. **RE-ENTRY:** Re-entry will be accepted only if the bowler bowled the previous day and on lane availability.
4. **ENTERING AVERAGE:**
  - a.) Entrants will use the highest 2019-2020 fall average of 21 or more games.
  - b.) If "a" does not apply, the bowler will use the highest 2020 summer average of 21 games.
  - c.) If neither a nor b apply the bowler will use their highest current average as of May 21, 2021 of 21 games or more.
  - d.) If none of the above apply the bowler will bowl scratch.
5. **USBC Rule 319a(2) DOES APPLY (10 PIN RULE).**
6. **USBC Rule 319e "AVERAGE ADJUSTMENT FOR ENTRY"** will apply.
7. **PRIZE REPORTING:** USBC Rule 319d "REPORTING PRIOR PRIZE WINNINGS" will apply.
8. **HANDICAP:** Handicap will be 90% of the difference between the bowlers entering average and 240.
9. **ENTRY FEE:** Entry fee is \$45.00 per person for Handicap ONLY Event or \$45.00 per person for Scratch ONLY Event or \$69.00 per person for both Handicap Event and Scratch Event. **NOTE:** That one set of scores will be used for both events if you get into Handicap & Scratch.  
**Entries received without ALL Entry Fees WILL BE RETURNED!** Prize fund returned 100% (Bowling and Expenses \$21.00, Prize Fund \$24/\$48) **SPECIAL NOTE: ALL entries received after deadline will be subject to a \$5.00 increase per bowler per event. WALK-INS: Will be accepted based on lane availability with the same \$5.00 increase per bowler per event.**
10. **REFUND:** There will be NO refund, after schedule dates have been assigned.
11. **BOWLERS RESPONSIBILITY:** Bowlers are responsible for verifying their own average. If the submitted average is lower than required and results in more handicap, the bowlers score will be disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average.
12. **TARDY BOWLERS:** Bowlers who miss one or more frames by not being present and ready to bowl when it is their turn, shall be credited with zero (0) pins for those frames missed.
13. **PRIZE DISTRIBUTION:** Prize money will be distributed at a ratio of at least one for every eight (1:8) entries.
14. **ENTRY CLOSING DATE:** Closing date is **May 8, 2021** at Midnight. All entries received AFTER closing date will be accepted based upon lane availability. **NO CONFIRMATIONS SENT; 1<sup>ST</sup> CHOICE UNLESS NOTIFIED**
15. Management reserves the right to re-rate or reject any entry prior to bowling for just cause.
16. Any rules not covered above shall be governed by USBC Rules.
17. **All Bowlers will be expected to comply with current Facility, City, County, State, Federal and CDC guidelines regarding COVID-19.**
