



SPACE COAST USBC BA YOUTH HALL OF FAME APPLICATION

RULES AND REGULATIONS GOVERNING APPLICATION FOR AWARD:

1. The Youth Hall of Fame will have two categories as below.
2. The Hall of Fame Committee will select nominees each year to be presented to the Space Coast USBC BA Board of Directors for final approval.
 - a. **SUPERIOR PERFORMANCE:** For outstanding performance as a bowler within the Space Coast USBC BA. (See qualification requirements on form.)
 - b. **LEGACY:** For those youth bowlers beyond the age of 18 who exhibited outstanding performance or contributed to the sport of bowling. (See last two pages for requirements)
3. Nominees must be or have been a member in good standing for at least three (3) years in the Space Coast USBC BA. The nominee does not have to be active at the time of his/her election.
4. Nominees must have bowled a minimum of three (3) years in the Space Coast USBC BA Youth Tournaments unless injuries or illness has shortened his/her career.
5. Any Space Coast USBC BA member may submit nominations. Nominations must be submitted by someone other than the nominee.
6. The nominee can submit this application at any time prior to their 18th birthday.
7. QUALIFICATIONS MUST BE WRITTEN AND SUBMITTED VIA MAIL OR ELECTRONICALLY BY: **JUNE 1st **
8. Incomplete applications will not be considered.
9. Nominees not elected will be carried forward for one (1) year only, after which they will have to be re-nominated for further consideration.

IMPORTANT: At least ONE (1) letter of recommendation and ONE (1) letter by the nominee on his/her consideration to be in the Hall of Fame is required when application is submitted.

LEGACY YOUTH HALL OF FAME

Space Coast USBC BA Legacy Youth Hall of Fame eligibility:

1. Nominees who are beyond the age of 18, who were members of the **Space Coast USBC BA Youth. The nominee does not have to be an active bowler at the time of his/her selection.
2. Nominees who exhibited outstanding performance or contributed to the sport of bowling while being a **Space Coast USBC BA Youth Member.

(** Nominees qualify who were Space Coast USBC BA Youth Members or being a former youth member prior to 2017 from the following bowling associations:
Florida Space Coast BA, North Brevard WBA, Indian River WBA, South Brevard WBA and Brevard-Indian River Youth)
3. Any Space Coast USBC BA member may submit nominations. Nominations must be submitted by someone other than the nominee.
4. The Space Coast USBC BA Hall of Fame Committee will make the selection of the Legacy Youth Hall of Fame.
5. At least ONE (1) letter of recommendation and ONE (1) letter by the applicant on his/her consideration to be in the Hall of Fame is required when application is submitted.
6. QUALIFICATIONS MUST BE WRITTEN AND SUBMITTED VIA MAIL OR ELECTRONICALLY BY: **JUNE 1st **
7. Incomplete applications will not be considered.
8. Nominees not elected will be carried forward for one (1) year only, after which they will have to be re-nominated for further consideration.
