## SPACE COAST OPEN TOURNAMENT RULES

**1. ELIGIBILITY:** This is a right to membership tournament. You may enter the tournament even if you are not a member of the Space Coast USBC, by having a current 2024-2025 USBC membership (no transfer fee will apply). PBA / PWBA MEMBERS: Not more than 1 professional member may bowl on any 4-member team, and not more than 1 professional member may bowl on a doubles team.

Senior Events for bowlers age 50 and over. Entrants must have reached their 50<sup>th</sup> birthday before **August 1, 2024**.

**2. TOURNAMENT FORMAT:** Tournament will consist of a Team Event (4 person), Doubles Event (2 person) and Singles Event. Bowlers entering doubles must enter singles and vice versa. Doubles and Singles will be bowled on the same pair of lanes.

**3. MULTIPLE PARTICIPANTS:** There are no multiple participants as there is only one shift for Team Event and one shift for Doubles & Singles Events.

**4. ENTERING AVERAGE:**

a.) Entrants will use the **HIGHEST 2023-2024 AVERAGE OF 21 GAMES OR MORE**, converted averages will be used if only Sport and Challenge shot averages exist for a bowler.

b.) If "a" does not apply, the bowler will use the **HIGHEST 2022-2023 AVERAGE OF 21 GAMES OR MORE**.

c.) If neither A nor B apply, the bowler can use their highest current average as of October 19, 2024, Bowler will need to bring all current recap sheets to prove their average.

d.) If none of the above apply the bowler will bowl scratch.

**USBC Rule 319e "AVERAGE ADJUSTMENT FOR ENTRY"** will apply.

**5. HANDICAP:** Handicap will be 90% of the difference between the bowlers entering average and 240.

**6. ENTRY FEE:** Entry fee is \$35.00 per Bowler, per event. Lineage & expenses are \$16.25 and Prize fund is \$17.75 for Team, Doubles and Singles Events and \$1.00 BVL/Cancer.

**Optional SENIOR ALL EVENTS Handicap** is \$10.00 each. Bowlers may choose to enter both, one or neither of the All Events. Prize fund returned 100%.

**Optional TEAM SCRATCH EVENT, DOUBLES SCRATCH EVENT & SINGLES SCRATCH EVENT** are \$10.00 each per bowler.

Bowlers may choose to enter all, one or neither of the Scratch Events. For the Team Scratch Event, **all bowlers** must choose to enter to be considered for this event. Prize fund returned 100%.

**Walk-Ins: Will NOT be accepted after the entry closing date.**

**7. REFUND:** There will be NO refunds after the entry deadline.

**8. PRIZE REPORTING:** USBC Rule 319d "REPORTING PRIOR PRIZE WINNINGS" will apply.

**9. REPLACEMENTS:** Substitutes will be allowed. Substitutes will bowl in the position of the absent bowler as submitted on the application provided the entrant does not violate rule #1

**10. BOWLERS RESPONSIBILITY:** Bowlers are responsible for verifying their own average, whether submitted by the bowler, the team captain, or others. If the submitted average is lower than required and results in more handicap, the bowlers score will be disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average.

**11. TARDY BOWLERS:** Bowlers who miss one or more frames by not being present and ready to bowl when it is their turn, shall be credited with zero (0) pins for those frames missed. Bowlers failing to show up to bowl will score 0.

**12. PRIZE DISTRIBUTION:** Prize money will be distributed at a ratio of at least one for every five (1:5) entries and ALL EVENTS will be 1:10. Scratch payout will be distributed at a ratio of at least one for every five (1:5) entries.

**13.** The Team Captain is responsible for notifying all entrants of dates and times they are scheduled to bowl and must check in all team members at least 30 minutes prior to squad time.

**14.** Errors in scoring must be reported, in writing, within 24 hours to the Tournament Director. Any protest or appeal affecting the playing rules or eligibility must be confirmed in writing to a tournament or local association official, or the United States Bowling Congress BEFORE the tournament prizes are awarded.

**15.** The Tournament Director reserves the right to re-rate or reject any entry prior to bowling for just cause.

**16. DRESS CODE:** Appropriate attire is required. THERE WILL BE NO TANK TOPS SHIRTS or SHORT SHORTS.

**17.** Any rules not covered above shall be governed by USBC Rules.
